Kindly be advised that with immediate effect, all appointed property agencies/agents who wish to advertise any property of the Masteron Group online and/or in the form of printed media must adhere to the guidelines set out below.

For KR7, the minimum advertisement price of the respective type shall be as follows:-

3 rd time		contract with immediate effect & no future claim toward the Company.

Agencies/agents will be given a grace period of 24 hours to remove/amend/adjust the advertisements accordingly as per the guidelines stipulated above.

The Management reserve all rights to amend/alter the contents/terms at any time.
